## **PREPOL07-Spate Conditions Policy**

## 1. Policy Introduction and Background:

It is the policy of Merseyside Fire and Rescue Authority (MFRA) to provide appropriate resources in the event of spate conditions or a large-scale incident.

## 2. Policy Explanation

As part of the risk management process extensive analysis of the levels of operational activity has been undertaken by an external consultancy. This empirical evidence has determined the reasonably foreseeable operational activity level and the number of appliances and other resources required to meet the authority's duty under the Fire and Rescue Services Act.

Spate conditions occur where the service experiences peaks of operational demand beyond the level of normal planned provision, which place pressure on the ability of the service to discharge its functions. These events may be widespread or localised, sudden impact or slow onset and may happen with varying degrees of warning or predictability.

Officers across the service have access to a variety of information sources that can provide early warning of situations that are likely to create spate conditions such as weather reports, industrial action, community engagement, meetings with partner agencies or national threat assessments. The documents supporting this policy provide a framework for such information to be reported and considered at tactical and/or strategic meetings and appropriate action taken to ensure any increases in operational activity can be managed.

#### Service Policy PREPOL07-Spate Conditions Policy

The Service will put in place arrangements to ensure that the equipment and personnel resources needed to manage spate conditions, can be put in place prior to predicted events, or brought into operation at short notice, in the event spate conditions occur without warning. This includes the use of contractual and voluntary staffing arrangements as well as 13/16 arrangements, national resilience arrangements, buddy arrangements with other FRS control rooms and national arrangements under Operation Willow Beck

The Service will put in place effective procedures for managing and prioritising attendance at incidents during spate conditions on a risk-based approach to ensure that life risk incidents are given the highest priority.

The Service will ensure through its mobilising arrangements that officers required to attend internal or multi agency tactical or strategic meetings have the correct level of training and have maintained competence to the required level in line with the principles in PODPOL04.
